LETTER FROM OUR PRESIDENT & EXECUTIVE DIRECTOR

CLAYWORKS HAS HAD A REMARKABLE TWO YEARS!

- Our adult class enrollment has steadily grown to nearly full capacity.
- Our Clayworks Mobile Studio has allowed us to significantly expand our community impact programs
- Our annual gala fundraising event—An Evening of Earth and Fire—grew both years and featured works donated by internationally recognized ceramic artists
- Our Clayworks gallery has opened
- Our visiting artist/collector events have been well attended
- Our studio artists and instructors hosted four open houses and sales to the public
- Our resident studio artist program has been at capacity
- Our programs have been featured in American Craft Magazine and on television
- Our donations from individuals increased
- Our community partners, such as the Arts & Science Council, have continued to support our programs and increase their support.
- Our budgets have been balanced and we have built operating reserves to ensure ongoing financial stability.

While these two years have brought Clayworks to a new level of recognition in and support from our community —and nationally—it brings with it new challenges. The increased use of our facility, purchased in 2011, has added "wear and tear," and we have experienced the repair, landscaping, renovation and maintenance that come with owning the physical plant. In the spring of 2107, Clayworks was able to replace the roof on both buildings. With the dramatic increase in programming, both in the studio and out in the community, we have challenged and stretched our staff, but have been able to add staff and expand jobs from part-time to full-time. It will be an ongoing challenge to ensure that we maintain the appropriate staffing levels with high caliber staff and instructors that maintain Clayworks' high standards.

Fortunately, our board is currently engaged in short and long-term strategic planning and strategic growth so that we are prepared to succeed in what looks like a very bright future for Clayworks. This bi-annual report covers both FY16 (7/1/15 - 6/30/16) and FY17 (7/1/16 - 6/30/17).

This report is a snapshot of an ever-evolving story that is Clayworks: the fourth largest ceramic arts educational facility in the United States that is dedicated to the promotion of ceramic arts, advancement of artists and students, and enrichment of the communities it serves. Stay tuned. The best is yet to come.

TWO YEARS IN REVIEW

FISCAL YEARS 2016 AND 2017 SHINE AS EXCITING AND SUCCESSFUL YEARS FOR CLAYWORKS. HERE ARE JUST A FEW OF OUR HIGHLIGHTS:

We hosted highly successful fund raisers in both FY16 and FY17, our fall galas. Through the generous support of Elder Gallery, which hosted both events, Clayworks was able to reach a broader audience and feature internationally recognized ceramic artists Mark Hewitt (2016) and David Stuempfle (2017) as special guest contributors, adding to an impressive lineup of many of North Carolina's top ceramic artists. *More than 700 people attended the Evenings of Earth and Fire.*





The Clayworks Mobile Studio reaches hundreds youth and adults each year who typically lack the means to take arts classes. These programs partnered with Charlotte-Mecklenburg Schools, YMCA of Central Carolinas, Charlotte Mecklenburg libraries, community centers and faith-based organizations. *More than 10,200 youth and over 5,300 adults participated in Clayworks Community Impact Programs*

Clayworks enjoyed steady growth of 68% from the previous two years in its adult student programs and expanded the types of classes offered. Clayworks resident studio artist program was at capacity in both FY2016 and FY 2017. Part of the Clayworks "magic" is our environment where students, instructors and studio artists work side-by-side. With 24/7 access to the studio, artists of all abilities take advantage of Clayworks being the fourth largest non-profit, ceramic arts education facility in the country. *More than 38,007 adults and children were served with programs*.





Clayworks offers visiting artist seminars, movie nights, and professional development opportunities for students, studio artists and the general public. As the hub of ceramic arts in an area that stretches from the sandhills to the mountains of North Carolina, Clayworks builds on the rich history of ceramic arts in our region. *More than 168 people attended Clayworks' special workshops*.

For each of the last 12 years, Clayworks studio artists, instructors and students, have made bowls to donate to Charlotte's Second Harvest Food Bank's Empty Bowls Project, an annual fundraiser to support feeding the hungry in Charlotte. *In twelve years, more than 3,600 bowls have been created and donated by Clayworks students and artists*



Clayworks gallery and semi-annual artist sales and open houses give the community an opportunity to see the caliber of work being done by students, instructors and



artists, and learn more about the ways that Clayworks is engaged in our community. From programs for disabled adults and disadvantaged children to world-class ceramic artists working next to beginning students, *Clayworks is a unique and special community, and we are proud that we continue to successfully accomplish our mission of serving our students, our artists, and our community.*
